


Chairman's Message

Organizational Profile

Sunny Trust provides Treatment and Rehabilitation services to drug addicts, with HIV/AIDS and IDU awareness to deprived communities.

Sunny Trust is a social sector development focused entity. It has been working since 1995, registered under Trust Act 1882 & under Voluntary Social Welfare Registration and Control Ordinance 1961. Sunny Trust is a non-profitable, non-political and non-sectarian organization. Sunny Trust is delivering services to strengthen the health and the social sectors in Pakistan. Sunny Trust is running 50 beds Treatment and Rehabilitation centre for drug addicts, health care services for outpatients and creating awareness among general public and high-risk groups particularly the information on the ill effects of drugs and transmission of HIV/AIDS in Pakistan.

ST so for has treated nearly 8000 drug addicts, covering practically all the social spectrum and successive generation of drug patients. Besides, Sunny Trust has treated overseas patients those of Pakistani origin from different countries i.e. Britain, Russia and Switzerland. The majority of drug dependents suffer from chronic diseases due to their prolonged history of drug abuse, repeated treatment and relapse. They are usually brought to this center as a last hope.

ST is the oldest and largest drug free, self-help programme in Pakistan. ST acts on behalf of those who seek help from problems compounded by substance abuse. Sunny methodology is based on Therapeutic Community (TC), a highly structured family environment where positive peer interaction is emphasized.

TREATMENT OF DRUG ADDICTS AND REHABILITATION

Drug

Any chemical substance of either synthetic, semi synthetic or natural origin that is used for its physiological and psychological effects.



Drug Abuse

Any use of drugs that causes physical, psychological, social, spiritual and legal harm to the individual or to the others affected by drug users' behavior.

Addiction

Addiction is state of being dependent on certain substance, which is harmful for the physical or mental health of the person, for his social well being and economical functioning.

Addiction can be defined as a physical or psychological dependence on a substance that is marked by;

- An increased intake
- Continued use despite consequences
- Physical withdrawal when use of drug is discontinued

Physical Dependence

It develops when user's body becomes totally dependent on the drug.

Psychological Dependence

It is a state characterized by emotional and mental preoccupation with the effects of drug and persistent craving for it.

TREATMENT

Intervention

The first step in treatment at Sunny Trust is to motivate the patient for treatment and bring him to rehabilitation centre, this is called Intervention. An effort to motivate, persuade or urge a person to change his/her attitudes or behaviors that are unacceptable by the community.

- An organized effort
- Carried out by significant or concerned others
- Meant to break through the person's denial and to diminish his/her delusion that has been pushing him/her to continue using drugs
- A collective effort planned after consulting experts or experienced people in field
- Aimed at securing the person's agreement to undergo treatment immediately

Purpose & Benefit of Doing Intervention

- Diminishing addict's addictive attitudes and behaviors like denying, blaming others, impulsive, compulsive, manipulative, etc.
- Bringing awareness to addicts about the impact of their destructive behaviors upon himself and others and that they need to focus on their treatment
- Obtaining addict's commitment to undergo treatment
- Creating an opportunity for other members to disengage themselves from the addicts
- Educating those involved how to be assertive and simultaneously eradicating their enabling behaviors
- Encouraging those involved to express their care and compassion to drug dependents
- Improving communication in a family
- Educating those involved exercising their right to voice out their grievances and concerns

- Family Intervention
- Peer Group Intervention
- Spouse Intervention
- Social Group Intervention
- Clinical Intervention

Guidelines for Treatment

- Recovery from addiction is possible
- Treatment program should be multidimensional and should be according to individual needs of client
- Adequate period of treatment is critical
- Involvement of family, community, workplace, and self help groups facilitate recovery
- Family, Patient and Doctor/Counselor make a triangle in recovery process
- · For sustained recovery regular monitoring is very important
- Relapse is probability
- Recovery is lifelong process
- All professionals work together like a team e.g. Doctor, Psychologist and Social counselors
- Knowledge and Will power plays a key role in treatment

2. Registration

After detail information family/guardian provides basic information about client including;

3. Detoxification

It is a process whereby individuals are systematically withdrawn from addicting drugs in an inpatient setting, typically under supervised care. Detoxification is sometimes called a distinct treatment modality but is more appropriately considered a precursor of treatment, because it is designed to treat the acute physiological effects of stopping drug use. Detoxification is not designed to address the psychological, social, and behavioral problems associated with addiction and therefore it is the first step of a comprehensive program of rehabilitation at Sunny Trust. It leads further towards;

- ASSESSMENT

- PSYCHO-SOCIAL ASSESSMENT

4. Counseling

Whether individual or group counseling is technique which involves;

- Insight
- Persuasion
- Suggestion
- Reassurance

This helps the client see himself and his problems more realistically and motivate him to find methods to cope. Drug counselors/Psychologists at Sunny Trust address issues of motivation, skills to resist drug use, facilitate interpersonal relationship and the individuals' ability to function in the community. Counseling techniques adopted by Sunny Trust includes;

- Individual Counseling
- Group Counseling
- Spiritual Counseling

- Family Counseling
- Group Lecture
- Group Therapy
- Follow-up
- Relapse Prevention Training

Recovery Process

"Recovery is the process of initiating and maintaining abstinence from substances as well as making intrapersonal and interpersonal changes".

Phases of recovery

After enrolment at Sunny Trust an addict passes through following stages of recovery:

Pre-Treatment

(Life before coming for treatment)

In Pre-treatment clients learn from the consequences and negative effects of drug use. As the consequences become more and more severe, they attempt to control their drug use. When this fails, they attempt periods of abstinence. Finally they admit defeat and realize that they cannot control their drug use.

Stabilization

(Withdrawal and Crisis Management/Detoxification)

Stabilization involves recovery from acute withdrawal and physical health problems under close supervision of Medical Officer and supportive counseling by staff members. They learn to break the psychological conditioning causing the urge to use drugs and stabilize the crisis that motivated them to seek treatment. This prepares them for the long term process of rehabilitation.

Therapeutic Communities

Sunny Trust provides high quality treatment and rehabilitation services for drug user

in its residential therapeutic communities. Therapeutic communities are highly structured residential environments or continuums of care in which the primary goals are the treatment of substance abuse and the fostering of personal growth leading to personal accountability.

REHABILITATION

Rehabilitation is a process by which an individual with drug related problem achieves an optimal state of health, psychological functioning and social wellbeing. Sunny methodology emphasizes following components of rehabilitation:

Components of Rehabilitation

- Physical Rehabilitation
- Spiritual Rehabilitation
- Social Rehabilitation
- Psychological Rehabilitation
- Vocational Rehabilitation

Physical rehabilitation

Physical rehabilitation in Sunny methodology emphasizes on Physical growth by the administration of proper medicine, appetite and exercise.

Spiritual Rehabilitation

An addict would experience a profound personality change after involving in drug addiction. His spiritual, mental, emotional and physical needs are fulfilled through a relationship with an object. To restore his sanity he needs to develop a relationship with a Power that is love, caring and more powerful than any others. The addict needs to acknowledge his powerlessness over his addiction and to freely submit himself fully and completely to a higher power .i-e. ALLAH.

Effective treatment in Sunny Methodology is aimed at Whole Person Recovery (WPR). This implies the need to address not only the physical damage and psychological distress that the drug addict is suffering from but equally important is the spiritual or religious fulfillment of the individual.

Spirituality is a potent force in recovery process. The recovering individual needs to reconnect to his Maker and in the process redefine his role as the vice regent on earth. This goal is achieved through participation in following activities at ST;

- Dars-e-Quran
- · Dars-e-Hadith
- Zikr
- · Spiritual counseling

Psychological Rehabilitation

Psychological rehabilitation of recovering addicts is achieved by Sunny Trust through following components;

Clinical Assessment

A detail clinical assessment by psychologists is essential for continuing care of these patients. The aim is to collect accurate information about the past and current drug taking behavior. Assessment is an initial step in determining the cause of addiction and identifying the most appropriate treatment modalities for client needs.

Individual Counseling/Psychotherapy

A team of experts in the field of psychology at Sunny Trust performs tasks of giving individual sessions regularly to patients.

Individual counseling is face to face interaction between Psychotherapist and patient. The main objective is to resolve the psychological conflicts, to change the thinking pattern and to modify the attitude towards drugs. This process involves teaching the clients to establish sensible priorities, to think carefully and resist impulses, to see the situation as realistically as possible, to share one's true feelings with psychologist and value other people's point of view and to accept the help and guidance from other person.

Group Counseling/Psychotherapy

Group therapy is a movement away from two persons' situation toward a group. The main objective is to develop interpersonal relationship skill amongst the patients, to enhance cooperation among them and to work as a team. At Sunny Trust group therapy is basic part of daily activity schedule in which patient is made aware of his problems, conflicts, abnormal behavior pattern, ego defense mechanism.

Family Counseling/Psychotherapy

Family psychotherapy is part and parcel of rehabilitation process. Involvement of family is essential in treatment as the patient can't recover in isolation and needs help and support of family members and significant others. Addiction is often called a family disease because it leaves its impact not merely on the abuser but on the members of his family as well. A family programme at Sunny Trust includes counseling, educative sessions, group sessions, individual counseling and an exposure to self-help programs.

The problems experienced during recovery and practical methods to deal with them are usually the focus of the educative sessions. In group discussions the family members are encouraged to share their feelings and problems. In the individual counseling sessions specific personal issues are handled, marital counseling is necessary as part of counseling.

Group Lecture

In group lectures given at sunny trust the Psychologist/ Counselor performs following tasks; Help the client to learn basic facts about nature of drug addiction, causes and effects of drug addiction, defenses, stages of treatment, recovery, recognizing the damage drug use has caused in one's own life. Clients respect the group not just by conforming to its norms but internalizing them. Thus the group serves as a micro-community that provides them with ample opportunities to develop and exercise self-discipline and social responsibility.

Follow-Up

Follow up is back bone of the rehabilitation program. The objective of the follow up is to keep the patient in touch with the treatment and rehabilitation program and overcome problems he faces in psychosocial aspect e.g. Post-Acute Withdrawal Management, Readjusting patient in to family and society. It emphasizes the importance of daily basis planning for recovering addicts. This is maintained for successful treatment and to sustain the motivation.

Sunny Trust offers three years follow up services to clients and ensures full sobriety.

Self-Help Group

"No one is so perfect that he needs no one else, and no one is so weak that he has to depend on others all the time".

A self-help group is an association of people with similar problems who organize themselves as mutual resources of support and guidance under supervision of Sunny Trust. It encourages each member to talk about their experiences, problems, feelings and what actions he has taken to overcome the situation. Self help group is a very effective technique to prevent relapse and to sustain his psychosocial potential. The patient is trained to develop group and arranges his meeting out side the hospital after completion of indoor treatment and rehabilitation.

The objective of self help group is to share and enhance their experience as a person in the main stream of community and society.

Relapse Prevention Training

Relapse is defined as an unfolding process in which the resumption of substance use is the last event in a long sequence of maladaptive responses to internal or external stressor or stimuli.

Relapse prevention is an important component of drug demand reduction strategies followed by Sunny Trust and calls for the support of various sectors of the community.

Relapse Prevention is a systematic method for recovering addicts to recognize and manage the recurrence of addictive behavior.

Relapse prevention training is strictly stressed at Sunny Trust in which clients are fully trained to prevent their relapse by developing new coping skills and making healthy life style changes.

Social Rehabilitation

This aspect of rehabilitation involves socialization of the patient in treatment setup as well as his reintegration outside the set-up. By participating in daily routine activities e.g. morning meeting, recreational activities, group therapy and lecture at Sunny Trust, patients learn to share their problems in a group, learn social norms and ethics. They learn to respect each other. All patients admitted in Sunny Trust comprise Sunny Family. It involves feedback and confrontation of behaviors, attitudes & self-disclosure. Treatment effects last longer and clients report greater satisfaction.

REINTEGRATION

Reintegration with Self

Drug addicts, who have been using drugs for a long time, often live in a very isolated world, cutoff from mainstream society. Their whole life is centered on drugs in one form or another. At first using drugs may be for fun or to gain social acceptance then it becomes a habit and finally a necessity for survival. Once addicts come to realize that they are powerless over their drug addiction and life is unmanageable, they become open to seeking alternative forms of help.

However, the road of recovery is not an easy one as the addict has taken drugs to help him cope with life's difficulties. The pain and absence of drugs can lead to vacuum and intense feelings of desperation and anxiety. The addict person overcomes all the problems by participation in daily routine and goes through stages in the treatment and rehabilitation programme at Sunny Trust. He is fully supported by the Doctors, Psychologists, and Social workers of ST. He explores his underlying potentials, his existence and takes over the responsibility of his Recovery.

Reintegration with Family

Families of addicts do not acknowledge that problem exists: they develop behaviors (co-dependency) that help them deny, ignore or avoid difficult emotions. They don't talk about them as result family members learn to repress emotions and disregard their own needs.

Family support programme is corner stone of Sunny Methodology. Family services given at Sunny Trust include Education, Counseling and Support Group. In reintegrating recovering addicts with their families following steps are taken by the team of professionals;

- The first step is understanding and accepting co-dependency traits
- Instead of focusing on the addicts, shortcoming they are taught to recognize their own negative traits and make efforts to change them
- Family members are prepared to make a new beginning based on trust
- Efforts are made to discuss issues related to the families, planning activities for the future and discussing problems honestly and openly, listen ing to his views and suggestion helps bring the family closer and makes the recovering person feel that he is a part of the family
- The family members consciously make efforts to gradually reassign responsibilities to the recovering individuals
- Involving in hobbies to recovering addicts by family provides a feeling of self-worth and a sense of accomplishment
- Family members accept that it will take time for him to change positively. It is highly desirable to be patient and allow the recovering person to recover at his own pace

Reintegration with Society

The drug problem has proved to be one of the latest challenges that mankind is facing. There is no simple formula to solve it and it continues to defy various efforts and programs to control it. It is deeply rooted and indeed requires sustained and long term holistic solutions involving not only family, Government but no less important society. The Islamic approach which advocates the well being of the totality of what constitutes the human being could and should be able to significantly assist in combating the drug problem.

The Community can play an important role in recovery through its social organization where a great deal of emphasis is placed upon togetherness, unity, support and regular meetings at common points. This engagement helps addicts develop a network of social support and participate in community development initiatives, equally, this also inspires them to become organized and learn new life skills, leading to a change in the quality of one's thinking, feeling and action.

Sunny Trust has launched a community support programme in which popular community leaders from print and electronic media, faith based organizations and political background visit Sunny Trust and give re-assurance and moral support to our clients that they acknowledge their healthy life style.

Sunny Trust also arranges prevention programmes in collaboration with community to give them awareness about addiction as a disease not as a curse and also to diminish stigma which is a great factor in relapse.

PREVENTION

"Prevention is the cornerstone of all strategies adopted by Sunny Trust"

The problem of drug abuse & its aftermath upon society is no longer confined to any socio cultural or national boundary. Apart from its obvious sociological impact reflected in broken families and a rise in crime level, drug abuse also directly negates national efforts towards productivity. The rising demands for drugs among youth must be curbed & highly effective preventive strategies must be planned to prevent over new generation.

Primary Prevention is planned process, which aims to promote health by empowering people with the necessary resources to confront stressful life situations before they occur. It means avoidance of something from occurring, to keep from happening, to anticipate or counter in advance.

Prevention strategies are targeted towards educating people, to enhance their life skills, educating them on the causes and effects of drug abuse and providing alternatives to drug abuse.

Rationale

- Prevention promotes healthy individuals and consequently eases the burden on costly treatment demands
- Prevention helps save individuals and families from the ramifications of drug abuse

Strategies on Prevention Adopted By Sunny Trust

1. Educational Institutions based Drug Abuse Prevetion Programmes

The education in schools/colleges consists of a broad range of concerted activities related to teaching and learning experiences which tend to maximize opportunities for the intellectual, emotional, psychological development of young people. In any country its preventive drug education programme is the foremost strategy in combating drug abuse problem. Utmost effort should be given to preventive drug education in schools because;

- · Higher incidence of young drug abuser
- · Schools have the captive audience
- · Schools are ideally located and equipped to provide many of cognitive, affective and skill components that are considered essential for effective prevention
- · Schools are link between homes and wider community through which communication can pass in both directions
- · Schools are micro-communities within which a wide variety of educational, environmental and policy strategies can be implemented

Sunny Trust has launched different programs in educational institutions e.g.

"Stopping Drug Use Before It Starts" "Know The Drugs"

Sunny Trust Coordinated with Islamabad Police and arranged **Summer School Camp**. In this program shields were distributed from Sunny Trust among students who performed brilliantly in sports and recreational activities. Batches carrying antidrug slogans were distributed among students. "**Drugs No Never**" & "**Sports Not Drugs**" were theme highly emphasized.

Students from various colleges & universities like Quaid-e-Azam University, Shifa College, Islamabad College for Girls, Burn Hall College Abbotabad, F-7/2 College for women and Bahria University visit regularly to Sunny Trust & take case histories of drug addicts, observe treatment and rehabilitation plan implemented here & learn valuable information about nature of addiction as a disease.



Health Care Services

Each year Pakistan witnesses preventable deaths of nearly 400,000 children under-five and 20,000 mothers due to causes related to pregnancy and child birth. Among the under-five deaths, two-thirds are in the newborn period (first 28 days of life) and the remaining are largely due to pneumonia (13%) and diarrhoea (11%), Pneumonia is a seasonal calamity, where a number of cases start rising in November and peak around December & January each year. About 52,000 children in Pakistan die due to pneumonia, every year. Most of these precious lives can be saved by simple knowledge about prevention, treatment and promotion of some key measures at home and appropriate health care seeking practices. Each woman should receive counseling on recognition of danger signs among mothers and newborns, health care services and immunization of child. So, health education sessions are the basic need of general community.

Internship

ST has built a reputation for offering useful and worthwhile placements for University students pursuing a career in the welfare professions. Throughout the last academic year the Trust provided placements for students from different Institutes and the Psychology Departments. During these placements students worked closely with their field supervisors and key workers in the different units of the Trust. Twenty students were given chance of internship during last three years.

Economic Rehabilitation, vocational training & Capacity Building:

Capacity works as a catalyst for social and environmental justice. At capacity we believe that a fair and equitable society can only exist if everyone has a right to participate in the major decisions that affect their lives. Only the full public participation can be effective in devising strategies for social justice, eradication of poverty, and, a healthy environment.

HIV/AIDS

A vast majority of people with HIV and AIDS live in lower and middle-income countries. But HIV today is a threat to men, women and children on all continents around the world. Millions of people continue to be infected with HIV every year. In low- and middle-income countries, less than half of those in need of antiretroviral therapy are receiving it, and too many do not have access to adequate care services.

World AIDS Day provides an opportunity for all of us - individuals, communities and political leaders - to take action and ensure that human rights are protected and global targets for HIV/AIDS prevention, treatment and care are met.

AIDS can affect anyone. But it is clear that it is spreading faster to people who live in poverty and lack access to education, basic health services, nutrition and clean water. Young people and women are the most vulnerable. Women are often powerless to insist on safe sex and easily become infected by HIV positive partners. When people have other diseases like sexually transmitted diseases, TB or malaria they are also more likely to contract and die from AIDS.

Pakistan is currently classified by WHO/UNAIDS definitions as a low prevalence but high-risk country for the spread of HIV infection due to a number of varied factors that include:

- Low literacy rate
- High prevalence of sexually transmitted infections
- Limited safety in blood transfusions
- Increasing numbers of injecting drug users and use of contaminated needles
- High injection use rate, coupled with use and reuse of un-sterilized syringes and medical equipment
- Highly mobile refugee population

The number of new cases of HIV infection continues to rise; the most predominant is injecting drug use.

One of Sunny Trust's major thrusts is to conduct drug abuse, HIV/AIDS & IDUs prevention campaigns and awareness programs on an ongoing basis in the community at large as well as in educational institutions and low-income target areas.


Sunny Trust's main target groups are the youth because they are considered the most vulnerable group. It is worth nothing that people in the different setting are aware of Sunny Trust's assistance in creating awareness about drugs in the community. Other NGOs that also have access to these communities recognize and value Sunny Trust's role in reinforcing their initiatives and strategies.

The main objective of these campaigns and programs is to create awareness and educate people regarding the dangers in the abuse of alcohol and drugs and the impact of these on the health of the individual, the family and the community at large. It also aims to encourage those whose substance abuse has resulted in personal and/or social problems in order to develop a personal action plan to address their behavior.

Our hospital at Bhara Kahu, Islamabad is situated on main Murree Road. Patients come from different parts of the country. We have a close interaction with local communities. Most of the people of Bhara Kahu are illiterate & due to a rise in property prices, these people became millionaire by selling their inherited properties. So, these people use alcohol and other drugs during their leisure time. Similarly, their children are also becoming drug addicts. That is the major threat to local communities. ST is trying to create awareness against Injecting Drug Users (IDUs), HIV/AIDS and drug addiction through schools, colleges and local communities. Similarly our target is Rawalpindi, Islamabad and nearby villages, where we create awareness through banners, streamers and pamphlets.

Governance, Commitments, and Engagement Governance

A Board of Management runs "Sunny Trust", which has representatives from different walks of life. Apart from these there are also other representatives from the community like different committees from youth and professional institutions.

Sunny Trust operates through a Board consisting of 8 members. It is the policy making body. The Chairman is responsible to carry out the policy decisions of the Board; to write reports and proposals for new initiatives to the Board, to coordinate on-going work of the project in the field, to promote the development of the staff, and to represent Sunny Trust on any forum or consultation related to its programs.

Chairman of Sunny Trust is the overall in-charge & taking care of administrative matters as an executive officer. Sunny Trust is a system of 50-bedded hospital and its matters of management and arrangement are totally different from other organizations. As an administrator, chairman with an experience of 25 years in the field of drug addiction and psychiatry, takes care of patients. For the wellbeing of patients, he remains in the hospital during Eid and public holidays. So, no one can prove himself/herself fit for this post. All other departments and executive body members work under his supervision.

Sunny Trust has direct coordination with its stakeholders. All important matters like budget, annual report designing, designing new projects, selection of managers and changing in bylaws etc. is done through the suggestions and recommendations of executive members. Similarly, taking new initiatives, jobs placements, making Terms of References (TORs), HR/Administration related tasks and other decisions are taken with the directions of employees.

The workforce of STI comprises of a total of 35 employees at its Rehabilitation Centre at Bhara Kahu, which is suitable to the nature and scale of its activities; presently there are only 6 female employees, as ST requires a larger number of male staff to supervise male drug addicts.

Male and female serving in the same category are being paid comparable salaries and equal professional development opportunities in terms of different trainings at the programme staff and administrative levels. All staff members are encouraged to attend the in-house training sessions while for training elsewhere relevant staff members are nominated in line with their relevant field. During the last few years the ST staff members participated in various training sessions.

Comments on discharge by the patients and their families help us to improve our treatment & rehabilitation services. Similarly every family gives its comments on each meeting according to the policies of organization.

Sunny Trust has defined special procedure for monitoring its programmes effectiveness and their impacts on the overall progress of organization. New initiatives or change in existing procedures are done on the positive feedback of stakeholders.

Sunny Trust's programmes, internal governance and financial matters were evaluated by Pakistan Centre for Philanthropy (PCP) during 2010 & 14. PCP awarded certification to Sunny Trust on successful completion of its certification process and getting 82% marks.

GENDER AND DIVERSITY

Men and women often play different roles in society and accordingly they may have different needs. ST recognizes that discrimination is unacceptable and that it is in the interests of ST and its employees to utilize the skills of the total workforce.

ETHICAL FUNDRAISING

Main source of funding of ST are the receipts collected by patients. Contribution by prosperous families for poor patients is another source of funding for organization. Very little amount is also contributed by local communities & friends in the form of cash or other utilities like sugar, flour, clothes etc.

We didn't get funding from International donors. For getting tax-exemption status, STI has already got the certification from Pakistan Center for Philanthropy (PCP). We are hopeful to succeed in getting funds from National and International donors in near future.

To deal with the workers grievances, Sunny Trust has designed HR Policies, which clearly indicate the solution of their complaints/problems. Special committees are formed to solve the problems of staff members.

Forms are designed for complaints against executives, senior staff and managers, all decisions are taken on merit.

Sunny Trust is drug addiction hospital and it relies mostly on psychologists. So, the most of the training sessions are conducted for this category. We have the well-trained & best psychologists in the area.

Every psychologist got 70 to 80 man-hours per year training to improve the performance.

Similarly, security guards & other employees have under gone training of 50 man-hours during last year.

About 100% of the professionals are receiving regular performance and career development during the reporting year. Work plan for each employee is designed during a year – due to which every employee gets technical knowledge & skills.

Its governance consists of 8 members of Governance Body. Seven executive members are male and one is female. All members comprising age groups of 38 - 60.

Sunny Trust has already divided the salary structures in to different categories, i.e. junior staff, senior staff, executives, doctors/psychologists etc. Executive members don't get salary for their services. They visit from other cities and provide their services free of cost. Although there is no discrimination among gender category; Sunny Trust has given the equal opportunities, salary and working environment to female staff members.

It includes news releases, hanging of posters and steamers during its campaigns, newsletter, literature, awareness programmes etc.

Similarly, ST organizes No smoking day, Drugs Day and other festivals regularly. Communities, students & employees participate in these programmes & play a very active role in the referral of patients. All executives and staff members of ST are very strict in obeying the laws, HR policies etc.

There were total 120 participants including students of colleges and universities, teachers, social workers, parents and media. Workshop on Personal Grooming and Character Building of Police Officers


